1. TRADE NAME: APPLE TRAP (BODY TRAP)

Monitoring device to detect the presence of wasps, if used together with Vespokil (code: P-01011), and flies, if used together with the powder for flies (code: P-01027).

Monitoring device for the IPM application complying with UNI EN 16636:2015 Regulation, that must be applied to control regularly the pests' presence in a specific place for a defined time.

4. TECHNICAL SPECIFICATIONS:

Apple trap is made of polyethylene.

It is composed of:

- N.1 apple shaped body trap (base+cover) with funnel-shaped entrance for insects;
- N.1 metal hook;
- N.1 metal thread for the trap positioning;
- Transparent cover to easy the visual control.

Measures:

Diameter: 180 mmHeight: 140 mm

5. HOW TO USE:

Place Apple Trap in the following places:

Terraces, roofs, orchards, gardens, greengrocers, factories processing or storing fruits, vegetables, meat, beer, wine, alcohol and fermentable sugars in general, if used with Vespokil.

Terraces, roofs, orchards, gardens, farms and landfills (it can be placed both indoor and outdoor), food industries (in this case, it must be placed outdoor), if used with the powder for flies. In this case, we suggest an outdoor use, due to the bad smell of the powder.

Place the trap at 1,5 m height, easily controllable. It must be protected from the sun (for example, under the trees) and put in the air flow. Place a trap every 50 m².

The wasps and fruit flies attraction is made by the special odour coming from the trap once the liquid or the powder has been poured.

Suggested monitoring period: from February to October, according to the season temperature.

Suggested frequency of the controls: Control the trap every 7 days to check the quantity of caught wasps and fruit flies. In case the trap is full of insects or dry (evaporated liquid), or after 2 weeks, change the liquid or the powder.

Storage conditions: in a cool and dry room, temperature below 25°C and R.H. below 55%.

6. PACKAGING AND SPARE PARTS:

- 10 pieces per case (sales units);
- Pallet: 480 pcs/pallet; 48 cases/pallet; pallet: 80 x 120 x 170 cm (h).

The available spare parts are:

- Vespokil (bottle of 500 ml case of 6 pcs, code: P-01011)
- Powder for flies, in aluminium bag (pack of 1 pc; code: P-01027)

7. DISPOSAL CONSIDERATIONS:

Waste disposal should be in accordance with existing Community, National and local regulations.
