1. TRADE NAME: **EASY TRAP PHERO PACK**

Monitoring device for detecting the presence of food moths (*Ephestia kuehniella* and *Plodia interpunctella*). This trap has already been activated by a specific pheromone.

Monitoring device for the IPM application complying with UNI EN 16636:2015 Regulation, that must be applied to control regularly the pests' presence in a specific place for a defined time.

4. TECHNICAL SPECIFICATIONS:

Easy Trap Phero Pack is a monitoring device (glue trap). It is detectable by metal detectors.

It is composed of:

- Plasticized cardboard on both sides;
- Specific glue for agriculture;
- Detectable pheromone dispenser Phero-Si MD for *Plodia interpunctella* and *Ephestia kuehniella*, already introduced inside the trap;
- Metal eyes to hang the trap;
- Packs in PA (polyamide)/PE (polyethylene).

Trap size (assembled):

- **Length:** 155 mm
- **Width:** 105 mm
- **Height:** 160 mm (h)

Detectable pheromone dispenser size:

- **Height:** 20 mm
- **Maximum internal diameter:** 7 mm
- **Maximum external diameter:** 10 mm
- **Weight:** 1.6 g

Glue Area: n.2 areas 120 x 150 mm each

5. HOW TO USE:

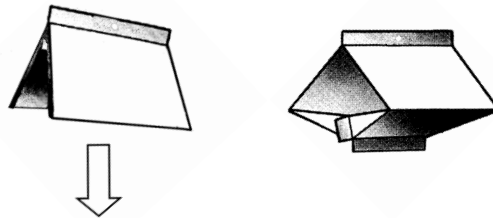
Place Easy Trap Phero Pack in the following places:

Inside food industries, storehouses, supermarkets, herbalist's shops, mills, pantries and all those places where it is stocked: wheat, cereals, biscuits, bread, pasta, chocolate, cocoa, candy, dried fruit, nuts, tea, camomile, tobacco, spices, etc.

The plastic coating of the cardboard makes the trap more resistant to dust, damp and water. The metal eyes can be detected by metal detectors, that's why Easy Trap Phero Pack is the ideal product for food industries, even for its easiness of assembly.

It must be placed at 1.8-2 m height.

Assemble the trap as follows:



We suggest you to give a number to each trap and indicate its placement in the monitored area plan, in order to facilitate the check during the periodic monitoring.

Theoretical covered area: 200 m².

Suggested monitoring period: all the yearlong.

Suggested frequency of the controls: weekly. Change the trap after two months (at the latest) or before according to the pest infestation or the presence of dust and water in the environment.

The use of the trap in dusty places could reduce the product functionality over time.

Storage conditions: in a cool and dry room, temperature below 25°C and R.H. below 55%.

If well stored (intact packaging), the product shelf life is 3 years.

During the life of the product, slight aesthetic defects may occur. These defects do not affect the effectiveness of the capture.

6. PACKAGING AND SPARE PARTS:

Trap:

- Packs of 3 pcs, Phero-Si MD Food included.
- Cases: 30 pcs (10 packs of 3 pieces each - sales unit);

Pheromone dispenser:

- Phero-Si MD Food (P-01048D): pheromone for *Plodia interpunctella* and *Epehstia kuehniella*.
